



## Declaration of compliance with safety instructions when staying at Teepee&Spa Pyskočely“

### I. Operator:

Represented by: Lenka Hrnčířik Hejduková

### II. Description:

The declaration applies to the use of Teepee&Spa – accommodation, whirlpool, sauna and scenic terrace in Pyskočely. Teepee&Spa has been designed for up to 5 persons including children. Full responsibility for children is borne by the legally competent person who accompanies them (legal guardian / responsible person).

### III. Safety instructions:

The operator lays down the following safety instructions regarding the use of Teepee&Spa. The resort may only be used by persons who agree to the instructions.

#### You are obliged:

- to confirm that you have no health problems at the time of making a reservation and during your stay (cardiological or vision problems; if you suffer from hypotension or hypertension, you must become acquainted with recommended procedures for the sauna; etc.)
- to have a fully charged phone during your stay
- to immediately communicate any changes or problems that occur during your stay

#### It is forbidden:

- to smoke inside the teepee
- to enter the scenic terrace, whirlpool or sauna intoxicated or under the influence of addictive substances.
- to bring valuables to the teepee; you may only bring movables necessary for your stay

#### Inclement weather:

- Inclement weather during your stay (strong wind, thunderstorm, etc.): The guests will be warned by the operator if very bad weather with gusts of wind exceeding 90 kilometres (56 miles) per hour is forecasted. If the guests fail to obey the weather warning, they will stay at Teepee&Spa at their own risk and on their own responsibility.

We who have made the reservation have fully acquainted all the participants with the rules and safety instructions, we have understood them and we will respect them. If we fail to comply with the aforementioned instructions specified in this declaration, we will bear full responsibility without entitlement to any refund.

## Consent to the processing of personal data

Teepee&Spa processes the registered subjects' personal data that have been provided to Teepee&Spa as part of the registration when making a reservation in accordance with the applicable laws of the Czech Republic, in particular with Personal Data Protection Act No. 101/2000 Coll., as amended. Personal data are collected through the <http://www.teepee-spa.cz> website. Personal data include personal information provided when making a reservation and when purchasing gift vouchers, namely: name and surname, email address, billing address, delivery address and phone number. By making a reservation at <http://www.teepee-spa.cz>, the customer agrees with the processing and collection of their personal data in the Teepee&Spa.cz database; such data are not provided to any other parties. Provision of personal data is voluntary, but if you fail to provide your personal data, the reservation process cannot be successfully completed, and the purchase of vouchers is only possible in cash upon agreement at the address of the Teepee&Spa office. Any registered subject may request, at any time, that all their personal data be deleted from the Teepee&Spa database. Any registered subject has the right to withdraw consent to the collection and processing of their personal data at any time at [info@teepee-spa.cz](mailto:info@teepee-spa.cz). Once the consent is withdrawn, all personal data will be erased from the Teepee&Spa database.
